
P/E FX STRATEGY FUND PROFILE

The P/E FX Strategy Fund is a sub fund of MontLake Oriel UCITS Platform ICAV, an Irish collective asset management vehicle constituted as an umbrella fund with segregated liability between sub funds with registration number C141639. The investment objective of the Fund is to generate returns by investing in foreign exchange markets. The investment objective of the Fund is to generate returns by investing in foreign exchange and global markets. The Fund is permitted to invest in financial derivative instruments ("FDIs"), including futures, forwards and swaps, as well as UCITS eligible exchange traded commodities ("ETCs") and exchange traded notes ("ETNs"), and money market instruments, including U.S. Treasury bills. ETNs are senior unsecured, unsubordinated debt instruments which provide access to returns based on the performance of an underlying financial product, instrument, or index. ETCs are asset backed notes that track the performance of an underlying commodity (such as gold) or a commodity index. The Investment Manager's strategy (the "FX Strategy") is focused on the international currency markets (as set out in the "Forecasting" section of the Supplement), including emerging market currencies (without limit) and commodities, such as gold.


